1. Financials

Reference A presented by NA, showing comparative income and expenditure statements (30 June 2025 vs 30 June 2023). Bathurst years generate surplus; non-Bathurst years generally result in a loss. Discussion on Bathurst event continuity – strong indication Six Hour event will continue with IPRA on the bill.

2. Bathurst 2025

Reference A presented by NSW. Event generated \sim \$60k over two years including \$30k of sponsorship. Positive exposure but high organisational load. External event management discussed as a potential solution. Risk of competitor choice between Nationals and Bathurst in certain years noted.

• Action: NA – Discuss online entry portal with Janelle Orrock

3. Bathurst 2026

State feedback indicated continued interest, though SA less enthusiastic due to limited track time. Consideration of a biannual Bathurst model to avoid conflict with long-distance Nationals.

4. Nationals 2025

Reference A presented by VIC. Eligibility determination required for Torana entry.

• Action: VIC - Submit NTC compliance review request for Torana modifications

5. Nationals - Future Planning

Reference A presented by NA. Post-Nationals participation boosts noted in WA, QLD, and NSW. Barriers include travel distance, cost, and uncertainty of Supercars event inclusion. Potential qualification system via early state rounds discussed.

- Action: All States Seek state feedback on national championship with qualification concept
- Action: All States Explore transport solutions for WA Nationals

6. Tyre Tender

Reference A presented by NA. Bridgestone contract negotiations to proceed despite concerns from SA (AS) regarding vote communication. Agreement to use production car tyre list for <15" wheels (unanimous).

- Action: All States Supply BSAL with tyre size/quantity requirements

7. IPRA Category Promotion

Reference A presented by NSW. NSW has extensive, high-quality footage; Nationals 2025 will be a major filming opportunity. \$5,000 approved for professional video production. Advertising budget in FB, YouTube & Instagram to be investigated after gauging organic response to videos.

9. Introductory Program

Introductory forms were reviewed and delegates agreed that there is benefit in continuing with the program.

10. Constitution Changes

Amendments were reviewed and a Special Resolution (se attachment) voted on and unanimously passed by delegates as per constitution's rule change procedure. Delegates undertook to make Club minutes available on websites or by (with addition re: member access to minutes). Agreement to update terminology (e.g., CAMS → Motorsport Australia). Voting structure discussion deferred for some states to discuss in further detail..

11. Code of Conduct

Reference A content reviewed.

11. National Administrators Position

The NA left the room for this part of the meeting.

All delegates agreed that the NA is completing the role effectively and invite him to continue the position for the following 12 months.

NSW raised a point relating to remuneration of the NA in accordance with the constitution. The Executive Committee (sans NA) voted to remunerate the NA through award of two paid race member entries, including garage hire, per calendar year.

12. Bridgestone Discussion

NA facilitated discussion with BSAL. NT tyre test discussed. BSAL Advised that excess camber would affect the inside edge of the tyre which is designed to manage wet conditions. BSAL offered a set up webinar for competitors including details on camber and monitoring tyre face temperatures. BSAL discussed next evolution of the tyre the RE71RZ tyre

(replacing RS) – improved lap times (0.5-1s based on Tsukuba development testing) and wear. RZ is next (fourth generation) of the Bridgestone tyre development and will replace the RS. BSAL advised an increase in tyre size options with the RZ. SA2 raised a tyre alignment sheet competitors could fill out and supply to branched for car setup

13. Rule Change Proposals

Reference A reviewed.

- NSW "Minimum Weights" proposal to be reconsidered pending SA Minimum Racing Weight anomaly outcome.
- SA to prepare revised minimum weight proposal
- SA engine configuration proposal to be circulated for state voting.
- VIC V8 restrictor proposal on hold until further advised. NT raised concept of CFM based restriction which would reduce impact on individual throttle body setups.
- QLD to continue rear wing measurement proposal development.
- Side intrusion foam options to be investigated by VIC.
- Action: SA Prepare revised minimum weight proposal
- Action: NA Distribute SA engine configuration proposal to states
- Action: VIC Investigate side intrusion foam options
